## **Terms & Conditions**



- 1. I will inform First Contact UK Mental Health immediately if I am unable to take part in the event.
- 2. Disclaimer: I agree that I am taking part in this event ("Event") at my own risk and that First Contact UK Mental Health shall not be held liable for any accident, injury, loss or damage incurred as a result of my participation in the Event, unless such accident, injury, loss or damage is caused by the negligence of First Contact UK Mental Health.
- 3. Health: I agree that I am responsible for my health and for deciding whether I am physically able to take part in the Event. If I am unsure about whether I am physically able to participate then I will obtain medical advice prior to the Event. I agree that if I need to drop out of the Event I will let First Contact UK Mental Health know as soon as possible.
- 4. Age: I hereby confirm that I am 18 years of age or older.

## 5. Entry:

- I agree to raise a minimum of £250 for the Event, which will secure my place on one of the One Man & His Fridge walk stages.
- I agree that I must complete the registration process with the event organisers in order to secure my place.
- I also agree that I must comply with all conditions of the Event as set out by the Event organiser.
- If the Event is cancelled or postponed, I understand that First Contact UK Mental Health will
  do everything they can to transfer my place to another time. However I acknowledge that

## 6. Sponsorship:
